

# Regulations for the Nice To Fit You Mini Marathon

## Regulations for the Nice To Fit You Mini Marathon

### I. Organizer

1. Organizer: The Nice To Fit You Mini Marathon is organized by the "Marathon Warsaw" Foundation, located at ul. Brylantowa 15, 05-077 Warsaw, Poland. The foundation is registered under NIP 9521913280 and REGON 015438288.

### II. Date and Location

1. The races will take place on September 28, 2024, in Warsaw, near the Palace of Culture and Science. The organizer reserves the right to change the location of the race, with notification provided to participants via the updated route on the website [nnmaratonwarszawski.com](https://nnmaratonwarszawski.com). Such changes will not result in any additional claims or obligations.
2. Categories, Distances, and Start Times:
  - a. for children up to 3 years old (born 2021-2024) – approximately 50 meters – starts from around 11:00 AM
  - b. for children aged 4-5 years (born 2019-2020) – approximately 100 meters – starts from around 12:15 PM
  - c. for children aged 6-7 years (born 2017-2018) – approximately 150 meters – starts from around 1:30 PM
  - d. for children aged 8-9 years (born 2015-2016) – approximately 200 meters – starts from around 2:30 PM
  - e. for children aged 10-11 years (born 2013-2014) – approximately 400 meters – starts from around 3:15 PM
  - f. for children aged 12-13 years (born 2011-2012) – approximately 600 meters – starts from around 3:45 PM
  - g. for children aged 14-16 years (born 2008-2010) – approximately 1200 meters – starts around 4:00 PM
3. Approximate Times: The provided times are approximate. Exact start times will be published on <https://nnmaratonwarszawski.com/> approximately one week before the event.

### III. Participation

1. Children aged up to 16 years (born in 2008 or later) are eligible to participate in the Nice To Fit You Mini Marathon.

2. Parents or legal guardians of children using wheelchairs must notify the Organizer of this fact via email at [info@maratonwarszawski.com](mailto:info@maratonwarszawski.com) after registering the child.
3. Each heat can accommodate approximately 80 children (40 children for the born 2021-2024 & 2019-2020 ). The Organizer plans to conduct one or several heats for each age category. Heats will be organized at 5 / 10 / 15-minute intervals (depending on the distance). The number of heats for each category will be determined by the Organizer. Assignment to a heat is automatic upon payment of the registration fee. There is no option to choose or change heats. The Organizer will notify about the exhaustion of available spots in a particular age category on the event website.
4. Participants will run independently (without a parent/guardian). Exceptions are the two youngest age categories (up to 3 years and 4-5 years), where a child may start with one parent/guardian. Older children with special needs may start with one parent/guardian if this is reported to the Organizer at the time of package pickup at the Race Office.
5. All participants must be verified at the Race Office. Verification can be done by the person registering the child or by a designated representative using the QR code received on the day the Race Office opens, along with a document verifying the child's age (a photocopy or photo of the document) and a parental/legal guardian consent form, available for download from the event website approximately two weeks before the race, signed by the parent/legal guardian.

6. At the Race Office, participants will receive their race packets, which include: race number, timing chip, and safety pins.
7. Race packets that are not picked up at the Race Office will not be mailed or distributed at a later date.
8. During the race, all participants must have their race numbers attached horizontally to the front of their shirt (or jacket). The race number must be visible throughout the entire race. Covering the number (either partially or fully) at any time during the race or altering it is prohibited and may result in disqualification.
9. The organizer will provide medical assistance at the start, along the course, and at the finish line during the race.

**IV. Registrations**

1. Registrations are accepted through the online forms available on the websites: [nnmaratonwarszawski.com](http://nnmaratonwarszawski.com) and [rejestracja.maratonwarszawski.com](http://rejestracja.maratonwarszawski.com).
2. Registrations must be completed by a parent or guardian from their account on the website specified in point 4.1.
3. A registration is considered complete when the following conditions are met: the registration form is filled out, payment for the registration fee is received and processed. Filling out the registration form alone does not guarantee a spot in the race.

4. Online registration will close on September 27, 2024. On-site registration will also be available at the Race Office of the Nice To Fit You Mini Marathon on September 27, 2024, only.
5. The organizer reserves the right to close registrations early if participant limits, as outlined in point III.2, are reached.

## **V. Fees**

1. The registration fee for participating in the race is 39.00 PLN per participant.
2. The registration fee can be paid online through the registration profile using the service PayU. PayU S.A. (Grunwaldzka 182, 60-166 Poznań, NIP 7792308495, REGON 300523444) is responsible for processing and securing online payments. PayU S.A. is a national payment institution regulated by the Financial Supervision Authority, listed in the Payment Services Register under number IP1/2012.
3. Proof of payment is the appearance of the participant's start number on the start list at [nmmaratonwarszawski.com](http://nmmaratonwarszawski.com). If the start number does not appear after 7 days, the participant must contact the organizer by phone: (+48) 503-860-516 or by email: [info@maratonwarszawski.com](mailto:info@maratonwarszawski.com).
4. The organizer is not responsible for the loss of registration or payment due to postal or banking errors.
5. Once paid, the registration fee is non-refundable and cannot be transferred to another person or another race organized by the „Warsaw Marathon” Foundation.
6. Participants who wish to receive an invoice for the registration fee should select the appropriate option in the registration form and provide the required details needed for issuing the document. The invoice will be automatically generated after the payment is processed and made available for download from the participant's profile by the 15th day of the month following the payment. According to tax regulations, since payment is made before the service is performed, a proforma invoice covering the full amount of the fee will be issued. The proforma invoice will also serve as the final invoice. By selecting the invoice option, the participant agrees to receive/send invoices without a recipient's signature in electronic form. This consent does not exclude the organizer's right to issue and send paper invoices.
7. To receive a Pro-Forma invoice, send the billing details, number, and list of participants (with registration numbers) to [ksiegowosc@maratonwarszawski.com](mailto:ksiegowosc@maratonwarszawski.com). Pro-Forma invoices are issued for a minimum of two participants (a Pro-Forma invoice cannot be issued for a single participant).

## **VI. Deposits**

1. Participants will have the option to deposit their belongings at a designated area. Items can only be retrieved with the start number. In the event of losing the start number, the organizer is not responsible for items being picked up by someone else. Note: Valuables and documents should not be left in the storage.
2. Participants will have access to changing rooms before and after the race.

## **VII. Classifications and Results**

1. During the Nice To Fit You Mini Maraton, the following classifications will be conducted for each age category (each classification combines the results of different waves):
  - a. Overall Classification
  - b. Overall Boys/Girls Classifications
2. Classification is based on electronic timing.

3. The overall classification is determined based on official times (gross – from the starter’s signal).
4. Unofficial race results will be posted on the website [nmaratonwarszawski.com](http://nmaratonwarszawski.com) immediately after the race.
5. Written protests concerning the results must be submitted by October 1, 2024, by 18:00 to [info@maratonwarszawski.com](mailto:info@maratonwarszawski.com). Protests will be reviewed within 96 hours, and final and official results will be published no later than October 14, 2024.
6. Certificates of completion for the Nice To Fit You Mini Maraton, available for self-printing, will be ready for download on [maratonwarszawski.com](http://maratonwarszawski.com) no later than 21 days after the event.
7. The organizer reserves the right to introduce additional classifications.

### **VIII. Prizes**

1. All participants who complete the Nice To Fit You Mini Maraton will receive commemorative medals at the finish line.
2. The top three finishers (1st, 2nd, and 3rd places) in the overall girls' and boys' classifications will receive commemorative trophies.
3. The organizer reserves the right to provide additional material prizes in selected categories and classifications.

### **IX. Personal Data Protection**

1. Participants' personal data will be processed in accordance with applicable regulations, particularly Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).
2. The processing of data mentioned in point XI.1 also includes the publication of: first name, last name, year of birth, town name, and club name.
3. Detailed information regarding the processing of personal data is provided in Annex 1 to these regulations.

### **X. Final Provisions**

1. Bicycles, roller skates, skateboards, other mechanical devices, and strollers are not allowed on the race course without prior permission from the Organizer. The use of Nordic walking poles and running with dogs is also prohibited. Only vehicles authorized by the Organizer with a valid permit are allowed on the course.
2. During the event, participants must adhere to the instructions given by those responsible for safety, security personnel, and other individuals designated by the Organizer.
3. The Organizer provides each participant with accident insurance (NNW) for the duration of the race.
4. The parent or legal guardian of each participant is required to sign a statement acknowledging the familiarity with the regulations. By signing this statement, the parent or guardian consents to the provision of first aid, other medical procedures, and transportation of the injured to a safe place by medical and paramedical staff acting on behalf of the Organizer.
5. The parent or guardian declares that the participant is fit to take part in the race, that there are no known health reasons preventing participation, and that participation is at their own risk. They acknowledge that the race involves physical exertion and carries natural risks of accidents, injuries (including death), and property damage. Additional

unforeseeable risk factors may also be involved. By signing the statement, the parent or guardian confirms they have considered and assessed the risks associated with the race, that participation is voluntary, and that decisions made by medical staff during the event are final and irrevocable.

6. By registering for the event, the parent or guardian accepts the regulations and agrees to the free use of the participant's image captured through photography or video. They grant the Organizer a free license to use the image for any exploitation, including recording and dissemination in any form, and for promotional purposes related to the Foundation "Marathon Warsaw." This includes use in promotional materials, publications, and media such as newspapers, websites, and TV and radio broadcasts.
7. The Organizer reserves the right to cancel or interrupt the race without providing reasons.
8. Placing advertising materials on race infrastructure (e.g., fences, gates) is the exclusive right of the Organizer and is specifically reserved for official sponsors/partners of the race. Placing any advertising materials on the race course or event areas (e.g., finish zone, race village) without the Organizer's consent is prohibited.
9. The binding and final interpretation of these regulations rests solely with the Organizer of the Nice To Fit You Mini Marathon. The Organizer will resolve any matters not covered by the Regulations. If any provision of the Regulations is found to be partially or entirely invalid or unenforceable, all other provisions (in whole or in part) will remain in effect.

### **GDPR INFORMATION CLAUSE**

#### **Who is the administrator of your personal data?**

#### **For what purpose and on what basis are your personal data processed?**

1. Providing Electronic Services:
  - Your participation in the race.
2. Execution of the contract: Your participation in the races you register for via the registration site ([rejestracja.maratonwarszawski.com](http://rejestracja.maratonwarszawski.com)), including:
  - Preparation of the starter package, insurance, results processing, award issuance, etc.
  - Publishing publicly accessible start lists and results.
  - Providing payment services.
  - Sending organizational information (email/SMS) about the races you register for.
  - Handling applications and correspondence directed to us.
  - Contacting you.
  - Enabling contact with the charitable organization you support (in the case of charity registration #BiegamDobrze).
3. Compliance with Legal Obligations:

- For tax and accounting purposes.
- 4. For Legitimate Interests of the Foundation "Marathon Warsaw":
  - Direct marketing of products and services.
  - Handling applications and correspondence directed to us.
  - Contacting you.
  - Preventing fraud and abuse.
- 5. Based on Your Consent:
  - Sending marketing information (email/SMS).

### **Do You Have to Provide Personal Data?**

Providing personal data is necessary both for your participation in the race and for managing your account on the registration site ([rejestracja.maratonwarszawski.com](http://rejestracja.maratonwarszawski.com)). Failure to provide personal data will prevent the conclusion of the contract and participation in the race.

### **How Long Will Your Personal Data Be Processed?**

Your data will be processed for the duration of your use of the registration site and participation in the races you sign up for through the site.

After this period, your data will continue to be stored for purposes required by law (particularly tax and accounting purposes), as well as for fraud prevention, abuse detection, and to pursue any potential claims arising from the contract.

Some of your data (especially those appearing in race results) may also be processed beyond this period for statistical and archival purposes.

### **Who Will Receive Your Personal Data?**

Your personal data will be disclosed to employees, collaborators, and subcontractors of the Administrator as necessary for the fulfillment of the aforementioned data processing purposes. Start lists and results, containing basic personal data, will be publicly accessible and published on the race website.

### **What Rights Do You Have Regarding the Processing of Your Personal Data?**

You have the right to request:

- Access to your personal data
- Rectification of your data
- Deletion of your data
- Restriction of processing

Additionally, you have the right to object to the processing of your data and to data portability. Furthermore, with respect to processing based on your consent, you have the right to withdraw your consent at any time.
